MUSIC DIRECTOR JOSE LUIS GOMEZ EXPANDED HIS ARTISTIC VISION TO INCLUDE A MORE ROBUST PLATFORM OF DIGITAL PROGRAMMING, WHICH FEATURED NEWLY RECORDED PERFORMANCES, MUSICIAN INTERVIEWS, CHILDREN'S CONTENT, AND DIFFERENT OPPORTUNITIES TO ENGAGE WITH MUSIC DIRECTOR JOSE LUIS GOMEZ THROUGH A VIRTUAL BOOK CLUB AND LISTENING CLUB. ADDITIONALLY, THERE WAS A COMPREHENSIVE OFFERING OF PREVIOUSLY RECORDED PERFORMANCES BROADCAST THROUGH MEDIA PARTNER, KUAT FM, THROUGHOUT THE SEASON. THE TSO DIGITAL STAGE REACHED OVER 40,000 VIEWERS FROM OVER 40 COUNTRIES AROUND THE WORLD.
